1. **Certificates of Insurance (COIs):** See your Agreement's Terms & Conditions, including Sections 30 and 31, for our full insurance requirements. Commercial General Liability and Automobile Liability Insurance policies required shall be for \$2 million per occurrence and name Additional Insureds with this language:

(i) *Metropolitan Arts & Antiques Pavilion, Ltd. and its Partners, Officers, Directors, Employees, Agents and Representatives are additional insured;* and

(ii) *Wasserstein Enterprises, LLC; ABS Partners Real Estate LLC and all Partners, Officers, Directors, Employees, Agents and Representatives of said entities, and Apple Bank for Savings, its successors or assigns are additional insured.*

d) Employer's Liability Insurance with limits not less than \$2,000,000 for each occurrence;

e) Automobile Liability Insurance with limits not less than \$2,000,000 each occurrence combined single limit for bodily injury and property damage, including coverages for owned, non-owned and hired vehicles, including loading and unloading operators; and
